Jawahar Navodaya Vidyalaya, Valasapalle, Chittoor district invites tenders for providing services of security guards for its vidyalaya at Valasapalle,

Reputed and experienced contractors having three years experience in this field may apply on the prescribed form IN SEPARATE SEALED COVERS COMPLETE IN ALL RESPECTS SUPERSCRIBED AS "TENDER FOR PROVIDING OF SECURITY GUARDS" addressed to

The Principal, Jawahar Navodaya Vidyalaya, Valasapalle, Madanapalle- 517 326 chittoor district AP, and drop in the sealed tender box kept for the purpose at vidyalaya office .

1. Interested tenderers may inspect the location of vidyalaya and can have the assessment of the campus.
2. Tender form can also be down loaded from JNV website i.e., www.jnvchittoor.gov.in . In case of downloaded tender for Rs. 200/- [Rs Two hundred only] as the cost of tender form may either be deposited in cash at the office and receipt thereof may be enclosed with the tender form or may be deposited by way of bank draft/pay order from any nationalized bank drawn in favour of Jawahar Navodaya Vidyalaya, Valasapalle, Madanpalle .
3. A lump sum of Rs. 20000/-[Rs. Twenty thousand only] shall be required to be submitted along with the tender form as EMD in the form of Crossed DD/PAY ORDER drawn on any Nationalized Bank in favour of JAWAHAR NAVODAYA VIDYALAYA, VALASAPALLE, MADANAPALLE. EMD of un successful tenderers shall be refunded at the earliest after finalization of successful contractor.

EMD of the successful tenderer shall be returned immediately after receipt of security deposit. No interest shall be paid on EMD in any case.

4. The successful tenderer will have to submit fixed deposit receipt in favour of JAWAHAR NAVODAYA VIDYALAYA, VALASAPALLE, MADANAPALLE as interest free security deposit equivalent to 15% of the annual tender value within 15 days of issue of work order for faithful performance of the contract. The same will be retained with JNV, till the contract period is over. In case of any violation of contract during the contractual period the security deposit will be liable to be forfeited. No interest shall be paid on performance security in any case.
5. Interested tenderes may submit their tender in sealed cover on the prescribed form duly complete in all respects together with photo copies of all the relevant documents and the envelop should be super scribed as "TENDER FOR PROVIDING SERVICES OF SECURITY GUARDS
6. Contractors with requisite experience may drop their offer in separate sealed cover

ELIGIBILITY CRITERIA:-

The company/firm/agency should have to complete the following requirement to qualify for applying for the aforesaid work.

- Company /firm/agency should be registered under relevant act of company/partnership etc., and should have a valid license under relevant contract.Labour Regulation and Abolition ACT 1970.
- Experience for providing at least 10 security guards personnel to at least last three Govt/semi Govt organization/Institute during last three years.
- The company /firm/agency should have a minimum turnover of Rs. 20 lakhs Per year in the last three year.
- Should have valid PF, ESI and service Tax /GST registration certificate.
- Company/firm /agency should not have been blacklisted from any Govt/semi Got Organization during the least five years.

SCHEDULE OF REQUIREMENT [Scope of work]

The scope of work includes watch and ward the inmates of the vidyalaya in particular students. Safe guard the vidyalaya property. Restriction of tress passers into the campus.

TERMS AND CONDITIONS OF THE CONTRACT:-

- The tenderer shall have to mention the following in its offer:

The successful tenderer will have to submit fixed deposit receipt in favour of "JNV, VALASAPALLE" as interest free security deposit equivalent to 15% of the annual tender value within 15 days of issue of work order for faithful performance of the contract. The same will be retained with JNV, till the contract period is over. In case of any violation of contract during the contractual period, the security deposit will be liable to be forfeited. No interest shall be paid on performance security in any case.

- The tender will be opened by a committee on the date and time specified above in presence of the tenderes /their representatives who will be willing to be present. No separate intimation will be sent to the companies/firm/agency for this purpose.

- The company /firm/agency shall be required to fulfill the eligibility criteria as given above of the document. However, the Principal of JNV, reserves the right to accept or Reject any or all the offers after opening of the tenders. No contractor has any right to demand the services at vidyalaya on the basis of his tender and rates quoted therein.
- The successful tenderer will have to enter into a separate agreement with the JNV and that the said agreement will be valid for a period of **two** years from the date of the acceptance. However the contract can be further extended with mutual consent on same rates and terms and conditions for a further period of two year, on annual basis, if JNV authority finds that the performance of the company/firm/agency in providing services at JNV, has remained outstanding/excellent during the period of service provided by the company/firm/agency.
- The contractor may inspect the building of JNV, prior to bidding to make an assessment of the campus.
- The contractor will have to provide adequate number of security guards as per requirement for the above mentioned services with proper identification badges. The contractor will offer the rates of minimum wages for security guards as fixed by the Central Govt., Ministry of Labour and Employment
- The contractor will have to ensure that the personnel is to be provided during the timings as per our requirement.
- Personnel engaged by the contractor for security guards should be punctual and disciplined. They should follow the instructions and directions given by the competent authority or the officers designated for maintaining for this purpose.
- The contractor will have to follow all the labour laws and local laws strictly and compliance of such local laws will be the obligation of the contractor.
- The contract is liable to be terminated with two month's notice from the agency.
- The contractor would provide distinct uniform to his staff.
- Any dispute between the contractor and his employees will be resolved by him without involvement of JNV in any manner.
- In the event of default of any of the conditions stipulated the EMD/SD will be forfeited and no interest on EMD/SD will be paid.
- If the services rendered by the contractor are found to be unsatisfactory at any stage, a penalty @ 5% of monthly bill due to default shall be imposed and deduction will be made from the bill. JNV shall be at liberty to take other such actions against the contractor as deemed fit and proper.
- The quoted rates will be Valid immediately after finalization of award of contract by JNV, to the selected company/firm/agency.
- Incomplete tenders or tenders without requisite EMD or defective EMD instrument will be summarily rejected.
- In case of any dispute between the company/firm/agency and NVS arising out of or in relation to the agreement, the dispute will be referred to the Arbitrator appointed by the competent authority whose decision will be final and binding on the parties.
- Any dispute arising out of or in relation between the parties will be subject to the jurisdiction at Madanapalle courts only.

- Rates may be quoted per month for one security guard for 8 hrs SHIFT duty and 12 hrs shift duties separately.
- The contractor shall at their own cost, if required take necessary insurance cover in respect of the aforesaid services rendered to JNV, and shall comply with the statutory provisions of relevant contract labour [Regulation and Abolition] Act, 1970, Employees state Insurance ACT, Workman's compensation Act, 1923, Payment of wages Act, 1936. The Employees Provident fund Act 1952, the payment of Bonus ACT, 1965. The minimum wages ACT, 1948, Employer liability Act, 1938, Employment of Children Act, 1938 and or any other rules/regulations and or statues that may be applicable to them and shall further kept the JNV, in demined from all acts of omission, fault, breaches and or any claim, demand, loss, injury and expense arising out from the on compliance of afore said statutory provision. For the contractor's failure to fulfill any of the obligations hereunder and/or under the aid acts, rules/regulations and or any bye-laws or rules framed under or any of these, the JNV, shall be entitled to recover any of such losses or expenses which it may have to suffer or incur on account of such claims, demands, loss or injury from the contractors, monthly payments.
- All pages should be signed and stamped by the proprietor/authorized signatory of the company/firm/agency before submission to JNV.

PAYMENT MODALITEIS:

1. **Payment shall be made on monthly basis. No advance payment will be made in any case.**
2. **The contractor has to submit bill in the first week of the succeeding a month and claim will be processed and paid by 2nd week of the month.**
3. **Release of payment is subject to deduction of penalty, if any and deduction of TDS at the prescribed rates.**
4. **Payment of service tax/GST is subject to tax abatement provision. The following are required during performance of the contractor.**
 1. **The contractor's staff shall not disturb the employees of the JNV or make any sort of noise in premises.**
 2. **The contractor's employees shall have to be polite, courteous, well behaved and honest with NVS employees.**
 3. **The contractor shall be fully responsible for any theft, burglary, fire or any other mischievous deeds done by its employees, the recovery of which will be made from the company/firm/agency.**
 4. **The contractor's employees shall be not enter into any unlawful activity within the JNV premises and shall have good moral character.**
 5. **The contractor shall be directly responsible for making the payment of wages to its employees which should not be less than minimum wages as prescribed the Central Govt of India, Ministry of Labour & Employment from time to time for the persons employed in the Central government offices. The company/firm/agency shall also be required to make payment of PF, ESI and any other benefits available under the rules to its employees. The JNV shall not entertain any such claim of the persons employed by the company/firm/agency.**

6. **Accidental Insurance of employees employed for work at JNV will be the responsibility of the contractor.**
7. **All the employees of the contractor shall be free from infectious diseases. Police verification and medical fitness of each employee has to be completed by the contractor before deploying them for work at JNV, at his own cost.**
8. **The employees shall report daily to the Principal/vice principal/OS or the person designated for the purpose before leaving the Office.**
9. The successful tenderer will have to enter into a separate agreement with the JNV and that the said agreement will be valid for a period of **two** years from the date of the acceptance. The agreement shall be executed on a non judicial stamp paper of Rs. 100/- incorporating all the terms and conditions of the tender. However the contract can be further extended with mutual consent on same rates and terms and conditions for a further period of two year, on annual basis, if JNV authority finds that the performance of the company/firm/agency in providing services at JNV, has remained outstanding/excellent during the period of service provided by the company/firm/agency.
10. **JNV shall pay the agreed amount to the company/firm/agency on monthly basis after completion of the month. In case the work of the security guards is found below satisfaction as per terms and conditions of the contract deduction of penalty as mentioned in the tender schedule shall be made from the monthly bill and warning shall be issued in writing. In case no further improvement is noticed, the work shall be terminated and security deposit shall be forfeited. The company/firm/agency shall be debarred from the JNV, for future works. In such circumstances, the services of security guards shall be awarded to the next company/firm/agency available in the panel.**
11. **The contract can be terminated without assigning any reason by giving one month notice in writing by the JNV.**
